Major General Alan S. Dohrmann assumed duties as adjutant general for the North Dakota National Guard in December 2015. As adjutant general, Major General Dohrmann commands more than 4,100 North Dakota Soldiers and Airmen and supervises approximately 1,325 full-time federal and state employees. He also serves as the Director of Emergency Services consisting of two Divisions: the Division of Homeland Security, and the Division of State Radio Communications.

Prior to his current assignment, General Dohrmann served as the deputy adjutant general from November 2010 to 2015. From 2009 to 2010, he was assigned as the Commanding General, Multinational Task Force East, Camp Bondsteel, Kosovo. General Dohrmann also commanded the North Dakota National Guard Land Component Command and served as the North Dakota Army National Guard's Chief of Staff. Major General Dohrmann was commissioned in 1983 through the Reserve Officers Training Corps program at Minnesota State University, Mankato.
